REPORT

This report, the tenth Annual Report of the Supervisor of Political Financing, is presented pursuant to Section 13 of the Political Process Financing Act, S.N.B. 1978 C.P-9.3 and covers the activities of my office for the period April 1, 1987 to March 31, 1988.

The Political Process Financing Act establishes general principles of political financing and sets out the mechanisms to ensure that these principles are observed and respected in practice. The Act:

- 1) places a limit on political contributions;
- 2) places a limit on the amount which may be spent to contest elections;
- 3) provides for the payment of an annual allowance to qualifying political parties from the public treasury;
- 4) provides for reimbursement of a portion of the election expenses incurred by qualifying candidates;
- 5) requires disclosure of the sources of funds made available to registered political parties, registered district associations and to registered independent candidates and of the uses to which those funds are put.

The Supervisor of Political Financing is responsible for the administration of the Act and for monitoring compliance with its provisions.

The Act provides for an Advisory Committee. The purpose of the committee is to serve as a conduit between the parties and the Supervisor, bringing the problems and concerns of the people involved in the political process to the attention of the Supervisor and giving the Supervisor the benefit of the members' experience and counsel.

Prior to December 8, 1988, the Committee was made up of two representatives from each party represented in the Legislative Assembly, the Chief Electoral Officer of the Province and the Supervisor of Political Financing.

The Acting Chief Electoral Officer, Scovil Hoyt and myself, as Supervisor.

An amendment to the Act, assented to on December 8, 1988, changed the basis of representation on the Advisory Committee to provide two representatives of each registered political party that had official candidates in at least one-half of all electoral districts at the immediately preceding general election, the Chief Electoral Officer and the Supervisor of Political Financing.

RAPPORT

Le présent rapport, le dixième Rapport annuel du Contrôleur du Financement politique, est présenté en vertu de l'article 13 de la Loi sur le financement de l'activité politique, L.N.-B., 1978, c.P-9.3, et couvre la période du 1er avril 1987 au 31 mars 1988.

La Loi sur le financement de l'activité politique formule les principes généraux se rapportant au financement politique et établit le processus pour que ces principes soient observés et respectés en pratique. La Loi,

- 1) limite les contributions faites à des fins politiques,
- 2) limite le montant qui peut être dépensé pour disputer les élections,
- 3) prévoit le versement, à même le Trésor public, d'une allocation annuelle aux partis politiques autorisés,
- 4) prévoit le remboursement d'une partie des dépenses électorales engagées par les candidats admissibles,
- 5) prescrit la divulgation de la provenance de fonds mis à la disposition des partis politiques enregistrés, des associations de circonscription enregistrées et des candidats indépendants enregistrés, ainsi que l'utilisation de ces fonds.

Le Contrôleur du financement politique est responsable de voir à l'application de la Loi et au respect des dispositions qu'elle contient.

La Loi prévoit la formation d'un Comité consultatif. Ce comité a pour but d'assurer la liaison entre les partis et le Contrôleur, faisant part à ce dernier des problèmes et des préoccupations des gens engagés dans le processus politique et de mettre l'expérience de ses membres au service du Contrôleur pour le conseiller sur l'application de la Loi.

Avant le 8 décembre 1988, le Comité était composé de deux représentants de chaque parti représenté à l'Assemblée législative, du Directeur général des élections de la province et du Contrôleur du financement politique.

le directeur par interim des élections, M. Scovil Hoyt et moi-même, le Contrôleur.

Un amendement à la Loi, sanctionné le 8 décembre 1988, a modifié la base de représentation au sein du Comité consultatif, qui se compose désormais de deux représentants de chaque parti politique enregistré qui avait des candidats officiels dans au moins la moitié des circonscriptions électorales lors de l'élection générale qui a immédiatement précédé, du Directeur général des élections et du Contrôleur du financement politique.

The Act requires each registered political party to file a semi-annual audited financial return. This financial return discloses the sources of contributions, other sources of funds and provides details as to how those funds were used.

Similar financial returns are required from each registered district association, except that the returns are un-audited and are submitted on an annual basis.

In addition to the Financial Returns, the parties and candidates were also required to file Election Period Returns for the 1987 General Election.

All of these returns have been reviewed by my office. The review was intended to monitor compliance with the Act and frequently necessitated follow-up to obtain additional information, clarifications and explanations. Where necessary, field audits were carried out to satisfy ourselves as to the completeness and accuracy of the returns.

Election expense reimbursements were paid to official agents of qualifying candidates.

The returns are kept on file at my office located at 618 Queen Street, Fredericton, N.B., and are available for public examination during normal business hours.

Schedules 1 to 9 appended to this report provide detailed information extracted from the 1987 Financial and Election Period returns.

The work involved in reviewing the election period returns together with the regular financial returns made for a busy year. I would like to recognize the efforts of my secretary, Anita Barchard, who has done an excellent job in very trying circumstances.

Mr. E. Neil McKelvey, O.C., Q.C., is retained as legal counsel to the Office of the Supervisor of Political Financing and the public accounting firm of Ernst & Young provides assistance in accounting and auditing matters.

I would like to acknowledge the cooperation and assistance given me by members of the Advisory Committee and by the representatives of all parties, candidates and district associations.

La Loi exige que chaque parti politique enregistré soumette semestriellement un rapport financier vérifié sur les contributions, les autres sources de financement et les détails sur l'utilisation des fonds en question.

Chaque association de circonscription enregistrée est tenue de déposer annuellement un rapport similaire, sauf qu'il n'est pas vérifié.

En plus des rapports financiers, les partis et les candidats ont dû également déposer un rapport financier de période électorale pour l'élection générale de 1987.

Chacun de ces rapports financiers a été étudié par mon bureau. Notre objectif était de vérifier si la Loi est respectée. Notre étude des rapports a souvent nécessité un suivi pour obtenir des informations, des clarifications ou des précisions additionnelles. Lorsque nécessaire, nous avons fait des vérifications sur place pour s'assurer que les rapports financiers étaient complets et exacts.

Les agents officiels des candidats admissibles ont reçu un remboursement des dépenses électorales.

Les rapports financiers sont conservés à mon bureau au 618, rue Queen, Fredericton, N.-B. et le public peut les consulter durant les heures normales de bureau.


Les annexes 1 à 9 du présent rapport contiennent des informations détaillées tirées des rapports financiers et des rapports financiers de période électorale de 1987.
