This report is presented pursuant to Section 13 of the Political Process Financing Act, S.N.B. 1978 C.P-9.3 and covers the activities of my office for the period April 1, 1993 to March 31, 1994.

The Act requires each political party registered under the Elections Act to file a financial return on a semi-annual basis. The return provides details as to contributions and all other sources of funds in addition to providing information on the uses to which these funds were put.

Similar financial returns are required of each registered district association, but on an annual basis.

The financial returns for the calendar year 1993 have been reviewed by my office. The reviews frequently required follow-up with official representatives to obtain additional information, clarifications and explanations, in order to satisfy ourselves as to the completeness and accuracy of the returns.

The official representatives have been helpful and cooperative in finalizing the returns, and I would like to acknowledge their assistance.

Schedules 1 to 5 attached to this report provide details of financial activities of the parties and associations extracted from the returns.

Schedule 6 provides details of the amounts spent in contesting the Moncton North (February 15, 1993), Carleton North (June 28, 1993) and Madawaska South (November 29, 1993) by-elections.

The financial and by-election returns are kept on file at my office located at Suite 3, 618 Queen Street, Fredericton, NB, and are available for examination during normal business hours.

The members of the Advisory Committee on the financing of the political process during the year were: Charles Sargeant and Yvon LeBlanc, representing the Liberal Party; Gerald A. Covey and Richard A. Finley, representing the COR-NB Party; Pierre Dubé and Lorne McGuigan, representing the P.C. Party; Robert Hall and Roger Couvrette, representing the N.D.P.; Barbara Landry, the Chief Electoral Officer, and myself, as Supervisor.

I would like to acknowledge the cooperation and assistance given me by members of the Advisory Committee and by the representatives of the parties and district associations.

Chaque association de circonscription enregistrée est tenue de déposer annuellement un rapport similaire, sauf qu'il n'est pas vérifié.

Les rapports financiers de l'année 1993 ont été étudiés par mon bureau. Nous avons dû consulter les représentants officiels pour obtenir des renseignements additionnels, des clarifications ou des précisions, afin de nous assurer que les rapports étaient complets et exacts.

Les représentants officiels ont fait preuve de collaboration en mettant au point les rapports, et je désire les remercier.

Les renseignements sur les activités des partis et des associations contenus aux annexes 1 à 5 sont tirés de ces rapports.

Les renseignements sur les dépenses des élections partielles de Moncton-nord (15 février 1993), Carleton-nord (28 juin 1993) et Madawaska-sud (29 novembre 1993) sont à l'annexe 6.

Ces rapports sont conservés à mon bureau au 618, rue Queen, app. 3, Fredericton, NB. Le public peut les consulter durant les heures de bureau.
