SCHEDULE 10 CLAIMS FOR ELECTION EXPENSES CONTESTED BY CHIEF AGENT

Every person to whom an amount is due for election expenses shall present his claim to the chief agent not later than 45 days following polling day. Otherwise, such person shall forfeit the right to recover the claim [*Political Process Financing Act*, subsection 76(1)].

Where a chief agent contests or fails to pay any claim for election expenses allegedly incurred by the chief agent or by a person authorized by him, the claim shall be deemed to be a contested claim. The claimant may bring an action in any court of competent jurisdiction to recover the claim [subsection 91(1)]. Claims for election expenses contested by the chief agent should be reported below [subsection 81(1)].

The particulars of any subsequent payment, including a payment in consequence of a judgment of any court, on any claim for election expenses allegedly incurred by a chief agent or a person authorized by him and previously listed as contested shall be disclosed forthwith to the Supervisor of Political Financing [section 84]. Such communication would occur subsequent to filing this Return.
